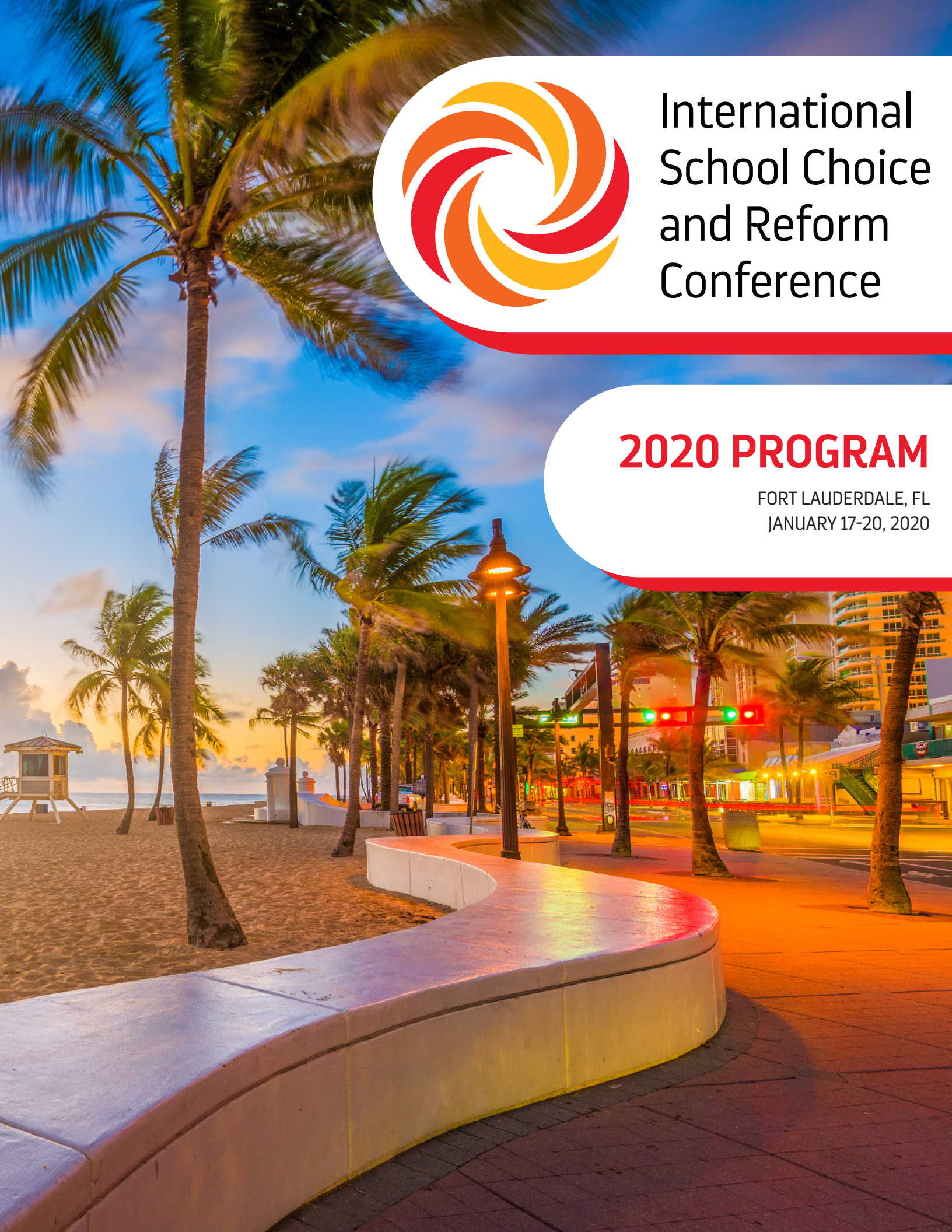

WELCOME

2006 marked the inaugural year of the *Journal of School Choice*, which was established to provide a forum for the study of the growing academic field of alternate educational delivery systems. The Journal was envisioned as an academic home for scholars studying charter schools, school vouchers, home schools, private schools, virtual schools and magnet schools. Since then, both the variety and complexity of alternative educational delivery methods has grown. Six years later, in 2012, the first International School Choice and Reform Conference (ISCRC) was—not accidentally—convened over the Martin Luther King Jr. Memorial Weekend in Ft. Lauderdale, Florida, to bring together some of the scholars who had, for the previous six years, been publishing in the Journal.

Thus was born the very special conference of which this is the program. Eschewing the multitudes who attend the annual meetings of the American Educational Research Association (~14,000) or the American Political Science Association (~7,500), the ISCRC traditionally brings together around 100 attendees whose attention is focused only on two things: the study of school choice and the intimate interaction of established and emerging scholars who value collaboration and academic rigor.

This year's program is the result of many hours of work by our dedicated Program Committee, chaired by Ben Scafidi, with Marisa Cannata, Tommaso Agasisti and Anna Egalite. Please join me and the rest of our Planning Committee in thanking them for this marvelous job.
